- Applicant must be a graduating senior from a high school in San Luis Obispo County, OR currently enrolled full-time at either Cuesta College or Cal Poly SLO continuing their college education in Fall 2026, OR any past San Luis Obispo County CattleWomen Scholarship recipient continuing their college education in Fall 2026 (college does not have to be in San Luis Obispo County).
- Applicants must be in pursuit of a degree or certificate at a 2-year college, 4-year college, trade or vocational school, or certificated program and enrolled in a course of study/major which directly or indirectly benefits the beef industry.
- Your *completed* application must be submitted on time and accompanied by the following...
  - Two letters of recommendation (no more than a year old) from individuals (non-relatives) who can attest to your involvement and contributions to the beef industry.
  - A copy of your current transcript (unofficial transcripts are acceptable)
- Late applications or applications/packets with missing components will not be accepted.
